The court's decision to depart was based on the same factors that the Parole Commission relied on to deny Wade parole, namely, that he is a violent offender who should not be released into the community because he presents an extremely high risk of reoffending. In addition, the court's conclusion that Wade presented an uncommon case in which the sophisticated means enhancement could not be applied and that his criminal history assessment suggested that a downward departure was warranted further supports our conclusion. Because the extent of the departure, 50% downward, is within the discretion of the trial court, we will not disturb it unless no reasonable person could have arrived at that decision.
