1. Field of the Invention The present invention relates to a method of manufacturing a semiconductor device having a circuit comprising a thin film transistor (hereinafter, referred to as TFT), and a semiconductor device manufactured thereby. More specifically, the present invention relates to the technology which is effective when applied to manufacture of electro-optical devices represented by a liquid crystal display panel.
2. Description of the Related Art In recent years, research and development have been extensively conducted on a technology of a thin film transistor (TFT) using a semiconductor thin film (having a thickness of approximately from several to several hundreds nanometers) formed on a substrate having an insulated surface. The thin film transistor is widely applied to electronic devices such as an IC and an electro-optical device, and development particularly as a switching element for image display device is demanded. Incidentally, in a liquid crystal display device, the image quality depends on a power consumption amount and a response time of a switching element used in each pixel. In order to reduce the power consumption amount and the response time, it is effective to increase the field-effect mobility (also referred to as the

NATIONWIDE BANKERS LIFE INS. CO. No. 20384. Court of Appeal of Louisiana, Orleans. April 28, 1953. *597 R. L. Whittington, New Orleans, for plaintiff-appellee. Halphen & Halphen, New Orleans, for defendant-appellant. REGAN, Judge. Plaintiff, Walter Earl Avignon and his wife, Bessie Walter Avignon, obtained a judgment against defendant, Nationwide Bankers Life Insurance Company, for \$5600.00, together with interest, costs and attorney fees, for breach of contract. The insurance company appealed suspensively and devolutively. From a judgment maintaining the exception to the jurisdiction of the court, it prosecutes this appeal. It is, therefore, necessary for us to determine whether the insurance company is a foreign corporation, the doing of business within the State of Louisiana being the test of jurisdiction over foreign corporations; or whether, being a domestic corporation, it is amenable to service in this suit under the provisions of Title 9, Sec. 47 of the Revised Statutes. The amended petition filed by the Avignons, appears to be for a collection from the insurance company, of installments of insurance premiums allegedly due, under a policy covering two insurance policies that had been issued to Bessie Walter Avignon by the insurance company in New York. *598 This suit is within the court's general jurisdiction, and not one for the recovery of property having been converted. The insurance company is a foreign insurance corporation licensed to do business in the State of Louisiana, and, not having consented to a non-resident suit, is amenable to the jurisdiction of the court.
